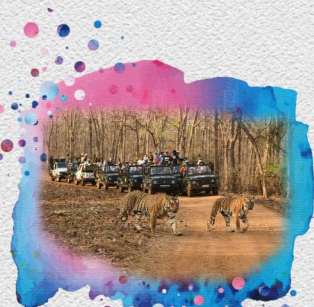

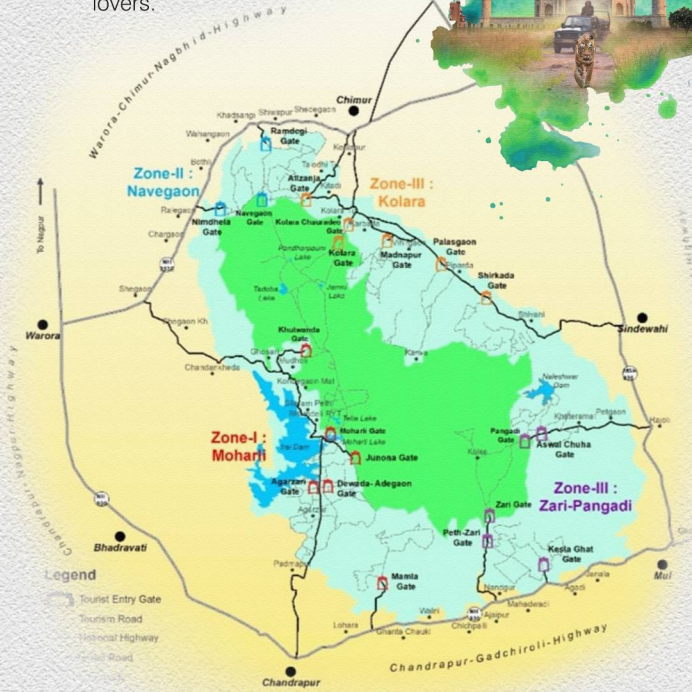


Why Tadoba...???
